RULES

1. ELIGIBILITY:

- Must be an Oneida Casino Players Club member, 21 years of age or older. Players Club membership is free.

2. PRIZES:

- Tournament payouts and payment structure based on number of participants entered in tournament.
- Payouts rounded to the nearest dollar amount without going over total prize.
- Prizes awarded in Oneida Casino cheques. Increment of cheques vary based on amount won.
- Oneida Casino Cheques:
 - Awarded by Poker Room.
 - Redeemable towards cash at any casino cashier or are playable at any poker or table games.
 - Transferable once participant signs for them.
 - Not awarded during Poker Tournament Play.
- No splitting of tournament payouts. The tournament will be played out in its entirety, until a winner is declared by having all Tournament Chips. The Tournament Supervisors decision will be final in all matters pertaining to the promotion.
- A valid photo I.D. and Players Club card required to claim prize payouts.
- Winners must provide a Social Security card, valid driver's license or picture I.D., Players Club card and complete a MISC TAX INFORMATION form prior to claiming prizes valued at five thousand dollars (\$5,000) or more.
- The Oneida Casino No Limit Texas Hold' Em Tournaments are self-funded, (by players/participants), not a casino funded tournament.

3. TO PARTICIPATE:

TOURNAMENT REGISTRATION:

- Tournament Day/Date/Times: Saturday March 22, 2025. Registration begins at 5:00 P.M. Tournament starts at 6:00 P.M.
- Valid Oneida Casino Locations: Main-Airport Location availability subject to change.
- Valid photo I.D. and Players Club card required at time of registration.
- Participants must register in person at the Poker Room (phone registration not accepted).
- No Refunds.

QUALIFYING TOURNAMENTS:

- Tournament based on ninety (90) participants plus alternates until first break. Twenty (20) minute levels.
- Buy-In is one hundred fifty dollars (\$150) for fifteen thousand dollars (\$15,000) in Tournament Chips.
 - One hundred twenty dollars (\$120) Prize Fund plus twenty dollars (\$20) for House, and ten dollars (\$10) for Dealers.
- Optional ten dollars (\$10) dealer token for five thousand dollars (\$5,000) in Tournament Chips before the first hand is dealt.
- No Re-Buys or Add-Ons.

TOURNAMENT PLAY:

- Existing Oneida Casino Poker Room rules apply unless specified.
- The Tournament Supervisor will assign all seats.
- All Tournament Chips must be kept separated by denomination and in full view of other participants.
- The Poker Dealer will call all hands.
- Participants cannot discuss cards in their hands or cards that have been folded until hand is over and pot has been awarded. Anyone caught cheating will be removed from tournament and will forfeit any remaining Tournament Chips to the Tournament Supervisor. Participants will not be allowed to play in any other tournaments and/or may be banned from Oneida Casino Poker Room.
- The Tournament Supervisor will settle any disputes. Once Tournament Supervisor decides, their decision is final, and tournament play begins. All decisions made by the Tournament Supervisor are final.

4. DISCLAIMERS:

The Oneida Casino Hotel No Limit Texas Hold' Em Freeze Out Poker Tournament is open to eligible participants 21 years of age, or older, except banned Casino patrons, Oneida Gaming employees, Business Committee/Gaming Commission Members, employees of participating vendors or individuals engaged in the development or fulfillment of, or supply to this promotion. Oneida Gaming employees may play in accordance with the Standard Operating Procedure entitled "Employee's Restriction on Gaming Activity." Eligible Oneida Gaming Employees must present gaming employee badge (displaying photo and badge number) prior to participating in self-funded tournaments.
